“Acknowledging there is a legal professionals standard that is in effect and recognizing that, while there is such standard, there is vast difference between legal professional’s remuneration and benefits in different institutions (especially judiciary and PG Office), and legal staff at Ministry’s are paid the lowest among all, despite the work we do.

As you may be aware, legal professionals in civil service do not have the privilege to be entitled unlike other institutions in this regard.

My work here at the ministry is more than just demanding. The work style at the ministry is reactive rather than proactive and often legal assistance is needed for “damage control”. I have worked as one person one unit for years- personally worked very hard for staff recruitment even though that’s not even my job. I am literally running after HR. With the new structure, I am still hopeful for new improvements will be made to the legal section.



While this is the case, I have been informed by HR that the request for my promotion was rejected by the Ministry of Finance. However, the same has been approved for colleagues at the AG office. And upon inquiry from HR, I was given a response that “they no longer give promotions as such” and there is “no update”

As you may be aware, the change in the rank is rather automatic, as it does not require public announcement to be made. It requires the staff to work for a certain number of years, and achieve At least 85% on the performance appraisal. And the next rank upgrade works in the same way subsequently. Thus delays in approving the first rank change, will delay the rank change in subsequent years, and affects me through my legal career here at the ministry entirely.

Also, If this ever gets approved, from which day does the change of rank be effective? From the day it's approved through bureaucracy or from the actual date my rank was to be changed?

While the legal professionals standard was made effective April 2014, my salary and position was changed according to the new standard only in December 2014, depriving my salary increment for 7 (seven) months, because it was made applicable only from the date of approval”
